- Coordinating **land use planning** efforts to ensure a positive impact of having the center-point junction of the Indianapolis-to-Evansville Interstate 69 development at SR231
- Implementing the Indiana **HomeTown Competitiveness** initiative, in particular, the design and development of a **Business Entrepreneurship** program that can be used as a prototype for regional application, and supporting the efforts of other Greene County agencies that are developing the remaining three ‘pillars’ of the program, i.e. capturing assets, youth and leadership development.
